A Personalized Philanthropic Strategic Plan

Give Canada's unique process begins with getting to know the donor and their family. We explore with them their values, interests and philanthropic aspirations. From there we help the donor formulate a detailed roadmap for giving, one that simplifies future decision making and maximizes the impact of a donor's gifts.

In order to help the donor create a legacy that aligns with their values, the Personalized Philanthropic Strategic Plan considers:

- » Past support a review of any annual gift pledges currently in place.
- » Current charities of choice.
- » Donor and family's interests by sector (education, health, sports, children, etc.) and specific charities.
- » The motivation for giving.
- » The preferred level of donation are smaller amounts to a number of different charities preferred to several significant gifts to a select few?
- » The preferred designation of gifts endowments, scholarships, buildings, centres of excellence or others.
- » Intended level of giving, including from a foundation (if applicable), its capitalization and any disbursement requirements.
- » Potential triggering events or future plans that affect a donor's giving.

2. Evaluation & Recommendations

With the Personalized Philanthropic Strategic Plan in hand, Give Canada is well poised to evaluate the donor's many funding requests and opportunities.

Together with our knowledge and expertise, we conduct additional research to make valid recommendations.

This includes:

- » A review of funding requests received by the donor and/or their foundation.
- » Researching, evaluating and sourcing potential charities that might fit the donor's current or future giving strategy and objectives.
- » Liaising between the donor and any not-for-profit organizations as and when required.
- » Presenting the donor with recommendations for suitable charities, including levels of gift, pledge period, potential donor recognition and any other relevant conditions.

3. Negotiation

Giving feels good. Unfortunately it is sometimes awkward and uncomfortable for the donor to finalize the details of a leadership gift agreement, especially when there is an existing and close relationship with the charity. Give Canada alleviates this situation by acting as a friendly facilitator.

Give Canada always represents the interests of the donor when negotiating gift agreements on their behalf. We help donors maximize the benefit of the gift and achieve optimal and preferential terms.

Fee Structure and Expenses
